**Short Term Rentals:** Multiple Airbnb rentals on Biltmore Drive and Roxbury Drive have resulted in complaints and have been reported to Sarasota County.

#### Safety Committee and Emergency Prep:

**<u>Traffic Updates</u>**: C.C. reported the permanent flashing speed sign on Markridge has been approved and a location has been selected. County will be installing soon.

#### **Deed Restrictions:**

Deed Restrictions committee is currently working on resolving violations with 12 properties, including 3 properties that have been referred for legal letters. Common violations continue to include visible boats, trailers, RVs, commercial vehicles, and signs.
